examinations from the year mentioned while granting affiliation/up-gradation regularly without break or inform with reasons thereof in writing well in time about the non-sponsoring of the candidates. Running of coaching institutions in the school premises in the pretext of providing coaching to the students for

various examinations is not permitted by the Board. Strict action would be taken on defaulters. The Manger and the Principal of the school shall be jointly responsible for the authenticity of the online/offline documents/information/data submitted by the School to the Board. appropriate decision in this matter The school shall renew all mandatory safety certificate i.e Safe Drinking Water & Health and Hygiene

certificate. Fire Safety Certificate and Building Safety Certificate from concerned Govt authorities time to time The school shall also maintain record of certificate, compliances, data and other records/information and shall be

fully responsible to produce all such records before Board and appropriate Government Authorities when asked for, failing which necessary action shall be taken as per Affiliation-Bye-Laws of the Board. The school shall also be liable for action by the appropriate Govt., in case of violation / non-compliance of the concerned Govt. norms 24.
